

Some of the catastrophic incidents that have completely changed the perception about the sources of threats to airport security forever include, the explosion of the Pan Am Flight 103 in 1988 flying from Frankfurt over Lockerbie in the United Kingdom, the unforgettable 9/11 terrorist attacks in 2001 on the World Trade Centre with devastating consequences, the 2006 terrorist attempt to attack with carry on liquid explosives on a number of flights operating between UK and USA , the explosion on Air India Flight 182 operating on Montreal Delhi route, the missile attack on Malaysian Airlines In 2018, and the terrorist attacks on landside/terminal buildings at Brussels, Istanbul, Glasgow and the Domedovo International Airport in Russia.

The current threat and risk environment demands that aviation security remains among the highest of priorities for the global international community. Despite enhancements to the security systems, terrorists continue to view civil aviation as an attractive target and continue to exploit real or perceived vulnerabilities in the international civil aviation system, with the aim of causing substantial loss of life, economic damage, disruption to connectivity and trade between airports/countries and gain media attention
